Hello Shipmates:



We have 3 new members in the flotilla and 3 members will have new ID cards.

We will be enforcing a rule about replacement IDs. You cannot get a replacement ID if you are not in uniform. The coast guard is checking all auxiliary IDs for expiration dates this is district wide.

Replacement ID Cards. Auxiliary ID cards are normally valid for five years before they require replacement. Replacement of an Auxiliary ID card should not be requested unless it has expired or will soon expire (i.e., within two to three months). A replacement ID card may also be requested if a current ID card is stolen or lost. However, in such a circumstance, written notification of the theft or loss must be made to the DIRAUX office, via the respective FC, as part of the request and it must reflect the circumstances of theft/loss as best possible (e.g., approximate date/time of theft/loss, suspected location of theft/loss, whether or not theft/loss was part of a report to authorities). Requests for replacement ID cards that do not include this information will not be processed. Requests for replacement ID cards shall be submitted per the guidance given above for new members, to include a properly completed ADMIN-11 and disk with photo.

Boat crew program – our flotilla currently has a very limited number of current and qualified boat crew members. In order for our flotilla to continue this valuable service we must advance our trainees.


Trainees – we will discuss the next step for your training at the June flotilla meeting.




Penn's Landing Safe Boating Day:

Sunday, May 24th




Paul Parravicini (FSO-VE) Completes a Vessel Examination...



...while Auxiliary member Dot French looks on.




Paul provides information to Safe Boating Day visitors

Two items of interest:

(1) The 2009 Light List contains several errors with respect to Private Aids to Navigation in the Delaware River. The 2007 Edition is correct. Apparently the new Light List was published from an electronic website and old information was picked up and printed. This problem probably exists nationwide, but just for PATONS. I have been in touch with the Auxiliary National NS officer who told me that they are aware of this problem, but no steps have been taken yet to correct the errors. The only PATON in the Delaware River that could be noticed by boaters is the South Jersey Dock Lights, just north of the Walt Whitman Bridge on the NJ side. There are two lights, each at the end of a pier. The 12313 Chart shows them to be Fixed Yellow lights, which is correct. The 2009 Light List describes them as being Quick Flashing Red - which is **WRONG**. However, when the lights were originally installed in 1986 they were indeed Q R!!!!, but were changed to F Y in 1993 to comply with IALA regulations. Somehow the compilers of the Light List used very old data with the new List.

(2) Some issues have arisen concerning the authority and responsibility for PATONS in NJ "State Waters". The role of the Auxiliary in verifying NJ PATONS may change. This is a legal matter being discussed between the USCG at District level and the State of New Jersey. When we know what the resolution is on this issue, I will pass in along. The only NJ state PATONS in our AOR are in Big Timber Creek, Chart 12312/12313.

*I want to remind Flotilla members that the http://www.nautical charts.noaa.gov website is updated weekly. Changes that are published in the weekly Local Notice to Mariners are applied to the affected charts at the same time. This is good to know.

Safety Alert

This Safety Alert serves to inform the maritime industry that energy saving Compact Fluorescent Lights (CFL) or lighting, sometimes known as radio frequency (RF) lighting devices may interfere with certain communications equipment. CFLs employ a RF lighting device to excite a gas inside a bulb in order to produce light.

The Federal Communications Commission (FCC) recognized the need for and adopted rules to control the harmful interference to radio communications services from these devices. During the rulemaking process the Coast Guard provided comments and recommended an advisory label for CFLs / RF lighting devices warning users about potential interference to communication services and particularly with respect to devices capable of producing emissions in the 0.45-30 MHz band. As a result, the FCC required manufacturers of CFLs to provide an advisory statement, either on the product packaging or with other user documentation, similar to the following: "This product may cause interference to radio communications and should not be installed near maritime safety communications equipment or other critical navigation or communication equipment operating between 0.45-30 MHz."

The Coast Guard has learned that CFLs have been installed on the navigation bridges of vessels and in other places capable of causing radio communications interference. Marine inspectors, vessel owners and operators **should be aware** of this potential safety hazard and take proper action as needed.
