U.S. COAST GUARD AUXILIARY MONITORING STATION PROGRAM

As part of the United States' effort to meet International agreements regarding the Global Maritime Distress and Safety System (GMDSS), the U. S. Coast Guard (USCG) broadcasts Weather Facsimile (WEFAX); Voice Broadcasts (VOBRA); Urgent Marine Information Broadcasts, using Narrow Band Direct Printing (NAVTEX); and Ice Information, using Ship Telex Over Radio (SITOR) messages and WE FAX.

Recreational, governmental and commercial vessels within the United States' (U.S.) 200-mile territorial limit must be able to receive those transmissions error-free to help ensure the safety of life and property at sea.

The USCG regards the end users of the broadcasts as its customers and considers itself in a provider/customer relationship. Therefore, maintaining a high standard of broadcast quality for the broadcasts (the product) is important to the USCG. Customer satisfaction is dependent upon timely, quality data that is received aboard a vessel in a readable and error-free format.

The USCG is responsible to provide a sufficient signal density throughout the 200mile territorial limit to ensure a receivable signal by its customers using commercial-off-the-shelf (i.e., average) receiving equipment.

Currently, the only mechanisms available to the USCG to gauge the effectiveness of their broadcasts are

1) self-monitoring on a limited basis, when and where possible, from USCG fixed and ship stations (as operations permit); and,

2) feedback from its customers, which usually only comes in when a problem exists.

Neither mechanism affords the USCG the reliable and proactive (preemptive) means of quality control it needs or desires.

PURPOSE

The purpose of this program is to provide a new mission for the U.S. Coast Guard Auxiliary (USCGAUX) in support of the USCG, as authorized by existing regulations.

PA Boating Law Change

The Pennsylvania Fish and Boat Commission passed a new regulation at its September 27, 2011, meeting on life jacket wear during cold weather months. <u>This regulation takes effect November 1, 2012</u>, and states that:

a person shall wear a Coast Guard approved personal flotation device (PFD or life jacket) during the cold weather months from November 1st through April 30th while underway or at anchor on boats less than 16 feet in length or any canoe or kayak.

HOLIDAY SUBSTANCE USE AND YOUR SAFETY

1. In the next few weeks many of us will be celebrating special occasions such as Thanksgiving, religious holidays, New Year's celebrations, and major sporting events. These events are often stressful as they require increased planning and travel to meet the demands of work and family expectations. Typically, these activities are full of fun, food, friends, and fellowship. For many, these events will include the consumption of alcohol. If you choose to drink alcohol, drink responsibly. Drinking responsibly means to know your limit and to understand that alcohol impairs your judgment and reflexes.

2. The CG has adopted an alcohol consumption model that fits both our substance abuse prevention strategy as well as our at risk model for both safety and health. 3. The CG has defined responsible drinking. Remember 0,1,2,3. Zero drinks when you must be alert and at the ready. This would include driving, while at work, and preparing for a mission. You should not drink if on prescription medication, pregnant, or preparing for other high-risk activities such as use of machinery, ladders, or cleaning a weapon. Zero is also the choice for any illicit drug or mood altering substance or prescription medicaine not prescribed for you. If you do drink alcohol remember 1,2,3. One drink per hour, two for any drinking occasion, and never exceed three drinks.

4. As you engage in celebrations over the holidays, remember that drinking alcohol and driving do not mix. Consuming any amount of alcohol compromises one's ability to drive and reduces reaction time. During the holiday season the roads will be busier than ever. More cars on the road result in more impaired drivers, whether from fatigue, medications, dristractions, poor night vision or alcohol use. Simply do not drink and drive or permit others to drink and drive.

5. Seemingly good times often go bad when excessive alcohol is consumed. The CG now has an abundance of data to demonstrate the negative impacts of excessive alcohol consumption. While statistics can never stop excessive alcohol use, it is noteworthy that one out of every two arrests in the CG is alcohol related. Choices such as "having just one more drink," not having an exit strategy, or riding with someone who has been drinking are seen as high risk behaviors.

6. If a shipmate is drinking too much, be a friend and be a leader and get them out of the bar or party. If he has consumed too much alcohol and/or appears drunk, help ensure that they return home safely. When hosting parties and events, include activities and holiday games that don't center around alcohol. Many communities have free or reduced taxi cab services over the holiday period. Call a cab or share a ride, but don't allow your shipmates to drive drunk. If you will be celebrating in a group, select a designated driver, the person who agrees not to drink alcohol and to drive the other group members home safely. Be a leader. Save a life.

7. Commanding officers are encouraged to have their cdars conduct an alcohol awareness inservice this month or in early December. Utilizing and enhancing your exercise regimes, practicing restraint when around the dining table and adding new activities can increase your level of enjoyment, resiliency and overall satisfaction.

8. Happy and safe holiday to all of our Coast Guard family. Make this be a joyful time with your family and friends. Look after each other, use common sense and take care of yourself. Show your dedication and commitment by being substance abuse free.
