The objective of this plan would be to spark interest of any type, shape, or form for the boating enthusiast, amateurs, and non- boaters alike who wish to learn about our public education offerings, boating safety and environmental protection. Your assistance is highly sought in this matter, for every member knows their community best and can better relate with their local media outlets. Members would be tasked in gathering the name of the local newspapers, community newsletter, or magazines right down to the Church newsletter, and provide them to the committee in charge. We will need a group of volunteers to develop a template that can be used for the ads so we can distribute them to the local media.

I'm confident that this could be accomplished if we all work at it together, and it might not happen overnight, but it is a step forward.

Lastly, let us be reminded that the Coast Guard is now looking at the Auxiliary more than ever. Training is always available somewhere in the 5NR and our classes are posted on the website. However, attendance from our own flotilla is still low, hopefully we can change that. We are never too old to learn something new, so please take advantage of all the offerings available to you and make yourself ready when we are called upon. Just recently national released a new program for members interested in participating in the medical field. This program is known as AUXMED, and it encompasses those who have skills in practicing medicine such as doctors, nurses, medical technicians and EMTs/ Paramedics. Members can provide assistance in teaching CPR and AED to active coast guard personnel or even our members of the auxiliary. # **Information Systems (IS)**

## Using AUXDIRECTORY

Have you ever wondered how to find someone to help you with your auxiliary needs? AUXDIRECTORY is the way to find someone because it lists everyone

who is in the auxiliary and their contact information. It also describes the organizational structure of the auxiliary and who fills those roles. The information in AUXDIRECTORY comes from AUXDATA, the central database for all auxiliary data. It is my job to keep AUXDATA up-to-date with the information you report. At the end of February 2012, I am enrolled in the AUX-10 C-school. When I return I will be able to update AUXDATA and use AUXINFO. You, too, can use AUXINFO! I will tell you how to do it when I return from school. In the meantime, all members should learn how to use the AUXDIRECTORY, also known as AUXOFFICER.

You can get to the AUXDIRECTORY by using the following link: <u>https://auxofficer.cgaux.org</u>. You will need two things,

• your employee ID

• your member zone password

Just click on the link to try it out. Your employee ID is on your ID card or in the letter that welcomed you to the auxiliary. Anyone who has access to the AUXDIRECTORY can get it for you. Your member zone password is the one you use to get to national and local auxiliary information. If you have forgotten it, you can get a new one. If you never got one, just go to AUXDIRECTORY and you can set it up.

The first thing you should do is verify that your record in the directory is correct. If it is not, I will help you correct it as follows. By navigating to your directory record you will see that the relevant personal information can be updated. Just correct it on the screen and press update. I will get a system-generated request with the information you want changed, and I will update it in AUXDATA. Otherwise, please send me an email or call me with the information.

# **UPDATED ODU AVAILABILITY AT THE COAST GUARD UNIFORM DISTRIBUTION CENTER (UDC)**

1. ALAUX 002/12 of February 2, 2012 provided an update to the surplus inventory of many Operational Dress Uniform (ODU) sizes at the Coast Guard Uniform Distribution Center (UDC) in Woodbine, NJ. This ALAUX updates the availability of ODU top and pant sizes at UDC.

2. As highlighted in yellow on the accompanying chart (<u>http://www.uscg.mil/auxiliary/odu-size-availability-feb12.pdf</u>), only two sizes are not available. All available ODUs may be ordered in multiple sets.

3. In order to manage and meet Coast Guard active duty demands, the UDC must reserve the right to adjust uniform availabilities as needed. It therefore highly recommends that Auxiliarists speak to a UDC customer service representative for updates on available sizes and place all their orders by phone.
