ACCOMPLISHMENTS

1. E-Mailed "Help Wanted" document to make sure that those members who did not attend February's meeting were aware of the need for staffing, etc., at future PA events.

- 2. Enlisted the help of four Flotilla members so far (Re. Item 1), one of whom (Shipsey) is taking photos of events she attends. News releases with accompanying photographs are far more effective than those without.
- 3. Have made preliminary contact with SO-PA Division 2, David Lau, and, D5NR DSO-PA, K.C. Murphy
- 4. Investigated potential locations for MS, PA, PE, and VE brochures/bulletins. Park managers at six (6) Pennsylvania State Parks have been contacted to one degree or another and we have received preliminary approval. I await receipt of form to be submitted for official approval. If approval is granted, and I see no reason why it shouldn't, it will be necessary to obtain the necessary literature, purchase literature holders and install, and set up a literature maintenance schedule.
- 5. Set up preliminary plans to meet with MX, PV, and VE Staff Officers to formulate a coordinated plan of action to raise public awareness and stimulate the publics' interest in our activities.

More flyers were distributed to all attending flotilla members at the February meeting. Thanks to Jimmy DeLeon for providing more flyers for distribution. Auxiliarists are urged to help publicize these courses by taking flyers to local marinas, bookstores, recreation centers, and marine supply stores. The courses are also currently listed on Craigslist Philadelphia.

New Jersey State Police Urge Safety for Early Season Boaters:

West Trenton, NJ – New Jersey has been fortunate this year with unseasonably warm weather. The spring-like days after a tame winter has already brought anxious boaters back out onto the frigid waters. Sometimes those adventurers pay for their enthusiasm with their lives. This year, State Police have received no notifications of cold-water-related deaths, but in 2010, five fatal boating accidents occurred in March alone in New Jersey.

The off-season months are very dangerous for boaters because of the increased speed at which hypothermia sets in when mishaps occur. Despite recent 60+-degree days, water temps on the Delaware River in the in the Trenton area are still in the mid 40s. The Atlantic Ocean is only in the low 50s, and deeper lakes in the state are about the same.

Falls overboard are the most common types of fatal boating accidents, and boaters hitting that frigid water quickly find their strength sapped and their movements slowed down. The human body cools down 25 times faster in cold water than in cold air. Within minutes of being in the water, people can lose manual dexterity, muscle coordination and breath control. When we each took the oath and were sworn into the Auxiliary, we accepted the responsibility and obligation to assist the Gold side in their mission. Well, Marine Stewardship is one of the Coast Guards ethos. There are only so many staff positions within the flotillas, divisions, etc. But just like each flotilla may have multiple Vessel Examiners, Program Visitors, Instructors and Boat Crew members. Each flotilla should have multiple MS – EP educated members. Training for most qualifications is done by active duty or reserve Coast Guard personnel, not by Auxiliarists. Training opportunities and policies vary from Sector to Sector so members should check with their MS Staff chain of leadership to determine the opportunities and policies in their Sector. This is a very prestigious award which takes a minumum of five years of training. It takes a real commitment on the part of the auxiliarist to fulfill the requirements necessary to obtain the qualifications and this device. 
