Reminder Risk Management Required by April 30th

- If you are in Auxiliary Elected leadership, Risk
 Management is required.
- If you are a Staff Officer for VE, IT, AV, CM, OP, MT, NS, and PA, Risk Management is required.
- If you are a VE, IT, AV, CM, PA, Interpreter, CPR
 Provider, First Aid Provider, AuxFS, AUXBUILD,
 Certified EMT, and Operations personnel that wish to stay current, you must have Risk Management to stay current. Also, if you working on the above

qualifications, it is required. NOTE This is not all inclusive but covers most of us.

Introduction to Risk Management needs to be completed by 30 Apr 19. The Risk Management course is found on the AUXLMS system with the course number 100202
